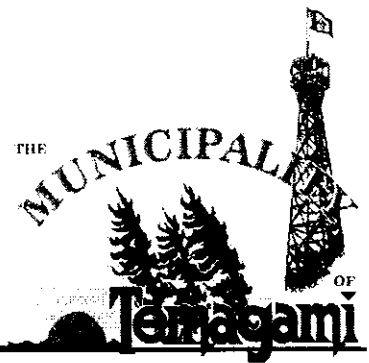

NOTICE OF NON-STATUTORY PUBLIC MEETING PLANNING ACT

Official Plan Review- Issue Identification

Re: Update of the Municipality of Temagami Official Plan in accordance with the provisions of Section 26. (1) and Section 26. (3) of the Planning Act.

Date: **January 27, 2009 1:30 p.m.**

Under Section 26 of the Planning Act, Municipalities are required, not less frequently than every five years after the Official Plan comes into effect or after a part of the Official Plan comes into effect, to carry out a review of the Official Plan. As part of that review, the Municipality is holding a special meeting to give a chance for summer residents to take part in the Official Plan review process, and to discuss the revisions to the Official Plan that may be required. The date for this meeting has been set for **January 27, 2009 at 1:30 p.m.**

At that meeting, the Council of the Municipality of Temagami will be considering whether revisions to the Official Plan are required to ensure that it:

1. Conforms with provincial plans or does not conflict with them, as the case may be;
2. Has regard to the matters of provincial interest listed in Section 2 of the Planning Act;
3. Is consistent with policy statements issued under Section 3 of the Planning Act; and
4. Adequately addresses other local land use planning related issues that have arisen since the Official Plan was approved or that may arise at this stakeholder meeting or that may arise during the course of updating the Official Plan.

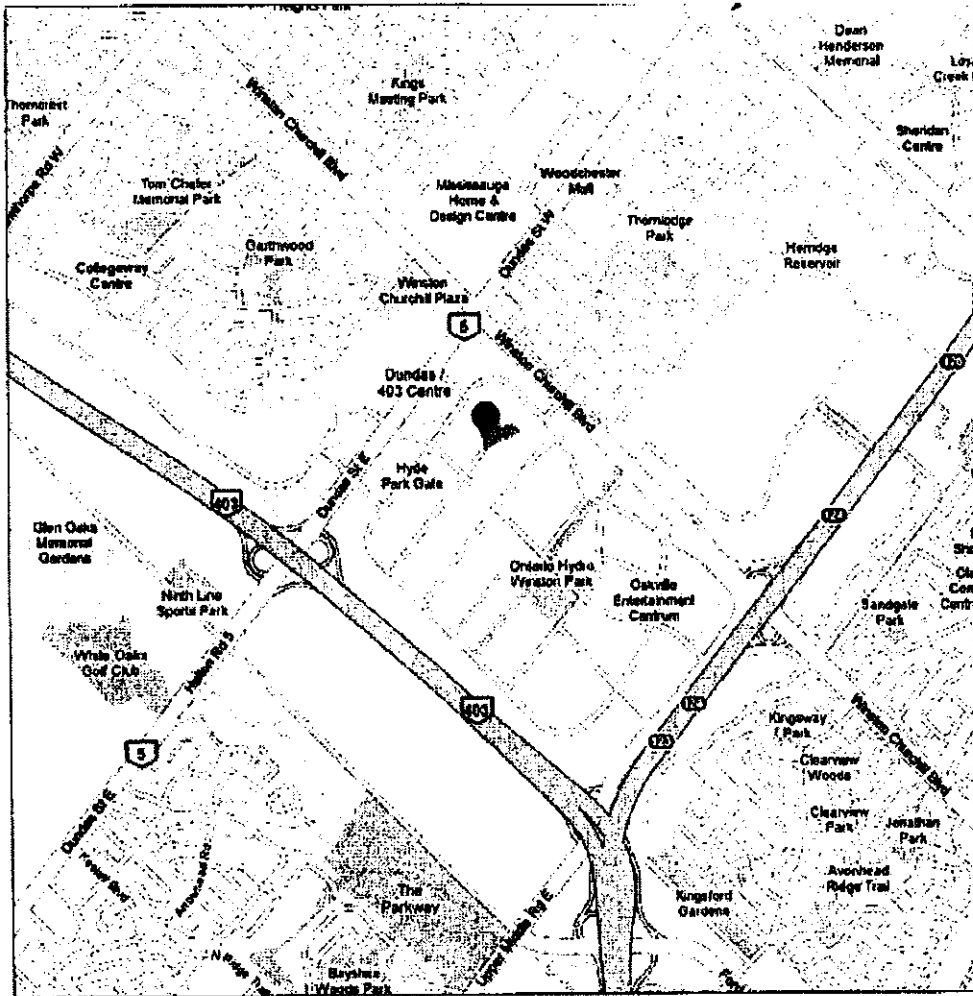
