10.1aii Cruiser Patrol Hours 65;

10.1aiii Staffing changes have a probationary constable coming to the Temagami Detachment.

10.1bi Violent Crime, Property Crime and Drug Crime statistics are all done in comparison to 2020: 11% decrease for Violent Crime from 2020, 19% decrease for Property Crime in comparison to 202 and Drug Crime showing no charges in 2021.

10.1biiClearance Rate is down slightly by 3% from 2020.

10.1ci Motor Vehicle Collisions – had a 22% increase from 2020.

10.1cii Speed indicated as the major factor in primary cause for Motor Vehicle Collisions.

10.di Criminal Code and Provincial Statute Charges Laid were down significantly from

2020: Highway Traffic Act charges down by 58% and Liquor License Act were up by 200%.
