

**THE CORPORATION OF THE
MUNICIPALITY OF TEMAGAMI**

BY-LAW NO. 14-1220

Being a by-law to assign Board and Committee responsibilities.

WHEREAS Section 226 of the Municipal Act S.O. 2001, c.25, as amended provides that a municipality may, with the consent of the head of council, appoint a member of council to act in the place of the head of council on any body, other than on the council of another municipality, of which the head of council is a member by virtue of being head of council;

AND WHEREAS the Municipal Act S.O. 2001, c.25, as amended, and other provincial legislation, such as the Public Libraries Act, R.S.O. 1990, chapter P.44; the Police Services Act, R.S.O. 1990, chapter P.15, and other applicable acts require the Municipal Council to appoint members to the local board for the term concurrent with the term of Council;

AND WHEREAS the Municipality of Temagami Procedural By-law authorizes Council to appoint the Chairs of the Standing Committees of Council;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami enacts as follows:

1. That Council members be appointed to represent the Municipality on various boards, commissions and bodies and to Standing Committees of Council as listed on Schedule “A” of this by-law and which may be amended from time to time by resolution of Council.
2. That By-law No. 13-1145 is hereby repealed.
3. That this by-law shall come into force and take effect on the final passing thereof.
4. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

Taken as read a second and third time and finally passed this 11th day of December, 2014.
