BY-LAW #89-^^/

Being a by-law to amend by-law #88-201, 'a by-law to regulate boat docking at municipal docks, by adding the following:

1 . No person who does not hold an authorized permit for a reserved boat docking space shall dock a boat at designated reserved spaces at the municipal docks.

2. Any person who contravenes any provisions of this by-law is guilty of an offence and liable to a fine not exceeding \$50.00.

Being a by-law to regulate boat docking at Municipal Docks.

WHEREAS the Council of the Township of Temagami deems it expedient to regulate boat docking at municipal docks .

THEREFORE the Council of the Township of Temagami ENACTS AS FOLLOWS:

1. Boat Docking Rates:

Footage -- Jw*e	Seasonal	Weekly	Daily
14'	\$330.00	\$22.00	\$3.85

<i>1989 Seasonal</i> <i>up to 19' = \$175.00</i> <i>20' + 24' = \$200.00</i> <i>Weekly = \$20.00</i> <i>Daily = \$3.00</i>			

2. The Township of Temagami and authorized delegates of the Township are hereby authorized to issue permits for the purposes of permitting boat docking at municipal docks.

3. The Township shall not be liable for the loss or theft of any property of the Owner left on the boat or on the Municipal docks .

4. The Owner shall notify the Township when removing a boat for more than 48 hours. The Township reserves the right to rent the dock provided herein when so vacant, for transient use.

5. If a boat sinks in the marina, the Owner shall remove such boat immediately. If the Owner fails to do so, then the Township may remove the boat at the Owner's expense.

6. No supplies, accessories, debris or other materials shall be stored on the docks. No unauthorized equipment shall be fastened to the docks. No refuse garbage, waste or debris shall be disposed of except within garbage containers supplied for the purpose.

7. No toilets or holding tanks shall be emptied at the municipal docks.

8. No person shall discharge oil, petroleum or petroleum products inflammable liquids, oily bilges or any deleterious material, noxious contaminated or poisonous substances within the Municipal docking area. If at any time and from time to time any pollution is caused to the water, by reason of or as a result of the operation of the Owner, as to all of which the Township shall be the sole judge, the Owner shall forthwith, upon receipt of a notice in writing from the Township, undertake, prosecute without interruption and complete the work of removal of such pollution material from the said waters, at the cost and expense of the Owner, to the satisfaction of the Township and in case the Owner fails to carry out its obligations under this section to remove such pollution

9. The Owner shall not suffer or permit to be done any act or thing which may impair, damage or injure the said land and the said facility beyond the damage occasioned by reasonable use, and shall at the Owner's own cost and expense maintain and repair portions of the said land and the said facility which may at any time be damaged by the Owner, other than in the reasonable use thereof.

10. Any pets shall be on a leash and under the control of the Owner.

11. No swimming is permitted in the marina facility.

12. No boat shall exceed the speed of 4 miles per hour in the Municipal Docking area. No boat shall impede the entry or exit of any other boat.

13. All costs or expenses incurred under this By-law - by the Township on behalf of the Owner shall, forthwith upon demand therefore be paid by the Owner to the Township and all such costs and expenses shall constitute a debt payable by the Owner to the Township.

14. Lease can be cancelled with a 7 day notice, by the owner for reason of excessive noise or disturbance of other users.

BEING A by-law to appoint a By-Law Enforcement Officer
for the Corporation of the Township of Temagami and
to rescind By-Law # &\$-22

WHEREAS the Council may appoint a By-Law Enforcement Officer
who shall have the authority of a constable with respect to
the enforcement of the By-Laws of the Municipality pursuant
to Section 70 of the Police Act, R.S.O. 1980, and the Council
deems it expedient so to do;

THEREFORE the Council of the Corporation of the Township of
Temagami ENACTS AS FOLLOWS:

1. That Dianne Berard be, and is hereby appointed By-Law Enforcement Officer for the Township of Temagami
2. That the saidj Dianne Berard shall hold office during the pleasure and subject to the By-Laws of the Council and shall with respect to the Corporation of the Township of Temagami and the enforcement of its by-laws, exercise all the authority, powers and rights and shall perform all the duties and obligations which by statute or by-laws are, or may be conferred or imposed upon the By-Law Enforcement Officer.
3. That the salary of the said Dianne Berard as By-Law Enforcement Officer of the Corporation of the Township of Temagami be payment in full for all services required of her, and all fees or emoluments of any kind accruing to her by virtue of an Act, Statute or By-Law shall be paid to the Corporation of the Township of Temagami and be credited to the General Funds of the Township of Temagami.
4. That By-Law # 68-22 be and is hereby rescinded.
