

THE CORPORATION OF THE TOWNSHIP OF TEMAGAMI

BY-LAW NO. 93-306

A BY-LAW to amend By-Law No., . 81-62, as amended.

WHEREAS upon the request of the property owner concerned, the Council of the Corporation of the Township of Temagami deems it advisable to amend By-Law No. 81-62, as amended;

NOW THEREFORE, THE Council of the Corporation of the Township of Temagami enacts as follows:

1. Schedule "A" to By-Law 81-62 is amended by changing the zone symbol on the lands designated "Zone Change from Residential to Commercial General "C1".
2. All use of land in the zones hereby established shall conform to all other applicable provisions of Zoning By-Law No. 81-62 except as hereby expressly varied.
3.
 - a. Written notice of the By-Law shall be given by the Clerk in the manner and form and to the persons prescribed by Section #34 of the Planning Act as amended by Bill 128.
 - b. Where no notice of appeal is filed with the Clerk of the Corporation of the Township of Temagami within twenty (20) days after the day that written notice was given, then this By-Law shall be deemed to have come into force on the day it was passed.
 - c. Where one or more notices of appeal are filed with the Clerk of the Corporation of the Township of Temagami within twenty (20) days after the day that written notice was given, seeking out objection to the By-Law and the reasons in support of the objection, then this By-Law and the reasons in support of the objection, then this By-Law shall not come into force until all appeals have been finally disposed of, whereupon the By-Law shall be deemed to have come into force on the day it was passed.

Read a first time in open council this 14, day of January, 1993.

Read a second time in open council this 14, day of January, 1993.

Read a third time in open council and finally passed this 14, day of January, 1993.

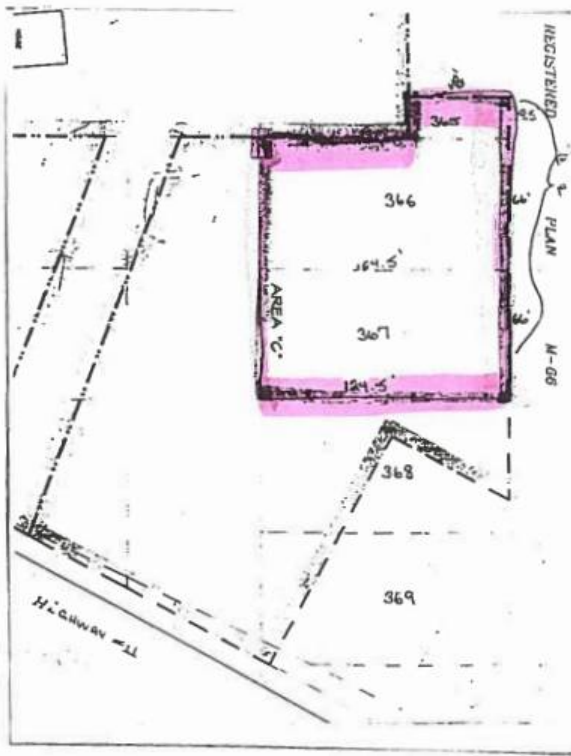
PUBLIC MEETING CONCERNING A PROPOSED
