

CORPORATION OF THE TOWNSHIP OF TEMAGAMI

BYLAW No. 93-314

BEING A BY-LAW TO CLOSE AND STOP UP PART OF THE ORIGINAL ROAD ALLOWANCE KNOWN AS LAKESHORE DRIVE, PLAN M-66

WHEREAS it is deemed expedient that the original road allowance set out and described in Schedule A attached hereto be closed and stopped up; and the land sold to the adjoining landowner; and

WHEREAS notice of this bylaw has been published once a week for four successive weeks in the Temiskaming Speaker, a newspaper published in the Town of New Liskeard; and

WHEREAS notice of this bylaw has been posted up for at least one month in six of the most public places in the immediate neighborhood of the said road allowance; and

WHEREAS the Council for the Corporation has heard in person or by his counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this bylaw and who applied to be heard.

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF TEMAGAMI ENACTS AS FOLLOWS:

1. That upon and after the passing of this bylaw all that portion of Lakeshore drive set out and described in Schedule A attached hereto be and the same is hereby closed and stopped.
2. All that part of the said Lakeshore Drive hereinbefore described and stopped up shall be sold to the adjoining owner: Ronald L. Prefasi for the sum of ONE THOUSAND FOUR HUNDRED AND SEVENTY-FOUR DOLLARS AND SEVENTY CENTS (\$1,474.70).
3. The Reeve and CAO of the Corporation of the Township of Temagami are hereby authorized to sign or execute such Deeds or other documents as may be necessary to effect conveyance of that part of the said road allowance hereinbefore described and which has been stopped up and closed.

4. There shall be attached to this bylaw as Schedule "B", the affidavit of John Hodgson, Chief Administrative Officer and Clerk of the Township of Temagami setting out the procedures taken for publishing and posting of the said notices pursuant to the provisions of the Municipal Act.

READ a first, second and finally passed upon third reading thereof this 17th day of May 1993.

FIRSTLY:

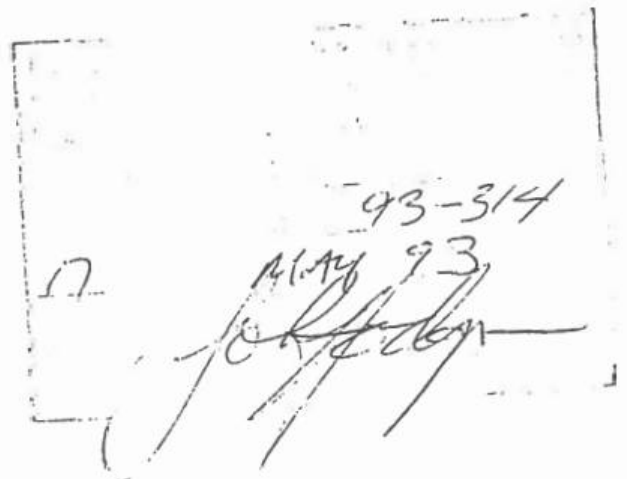
Part of Parcel 14137 Nipissing, being part 3 on Reference Plan 36R-6009;

John H. Hodgson, being the person signing the Affidavit, has knowledge of the facts.


Information with respect to the publication and posting, with dates and particulars:

^Confirmation from Public Works Canada stating they had no interest in these lands.


The proposed bylaw came before municipal council on the 17th day of May, 1993 and no one appeared in person or by counsel to make representation with respect to the proposed bylaw.
