NP 93-335 CORPORATION OF THE TOWNSHIP OF TEMAGAMI

BYLAW No. 93-315

BEING A BY-LAW TO CLOSE, STOP UP AND SELL PART OF THE ORIGINAL SHORE ROAD ALLOWANCE IN FRONT OF (COMSTOCK PROPERTY)

WHEREAS it is deemed expedient in the interest of the Corporation of the Township of Temagami, hereinafter called the Corporation, that part of the original shore road allowance set out and described in Schedule "A" attached hereto be closed and stopped up for both vehicular and pedestrian traffic and the lands sold to the adjoining land owner;

AND WHEREAS Notice of this Bylaw has been published once a week for four consecutive weeks in the Temiskaming Speaker newspaper, and has been posted up for at least one month in six of the most public places in the immediate neighourhood of the said unopened road allowance;

AND WHEREAS the Council for the Corporation has heard in person or by his counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this bylaw and who applied to be heard.

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF TEMAGAMI **ENACTS AS FOLLOWS:**

1. That upon and after the passing of this bylaw all that portion of the original shore road allowance set out and described in Schedule A attached hereto be and the same is hereby closed and stopped uj/

2 All that part of the said shore road allowance hereinbefore described and stopped up shall be sold to the adjoining owner.

3. The Reeve and CAO of the Corporation of the Township of Temagami are hereby authorized to sign 0r execute such Deeds or other documents as may be necessary to effect conveyance of that part of the said original shore road allowance hereinbefore described and which has been stopped up and closed.

4. There shall be attached to this bylaw as Schedule "B", the affidavit of John Hodgson, Chief Administrative Officer and Clerk of the Township of Temagami setting out the procedures taken for publishing and posting of the said notices pursuant to the provisions of the Municipal Act.
