

CORPORATION OF THE TOWNSHIP OF TEMAGAMI

BY-LAW NO. 93-325

BEING A BY-LAW TO CLOSE AND STOP UP PART OF THE ORIGINAL
ROAD ALLOWANCE IN FRONT OF
(JOEL BELANGER PROPERTY)

WHEREAS it is deemed expedient in the interest of the Corporation of the Township of Temagami, hereinafter called the Corporation, that part of the original road allowance set out and described in Schedule "A" attached hereto be closed and stopped up for both vehicular and pedestrian traffic and the lands sold to the adjoining land owner;

AND WHEREAS Notice of this By-Law has been published once a week for four consecutive weeks in the Temiskaming Speaker newspaper, and has been posted up for at least one month in six of the most public places in the immediate neighborhood of the said unopened road allowance;

AND WHEREAS the Council for the Corporation has heard in person or by his counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this By-Law and who applied to be heard.

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF TEMAGAMI ENACTS AS FOLLOWS;

1. That upon and after the passing of this By-Law all that portion of the original road allowance set out and described in Schedule A attached hereto be and the same is hereby closed and stopped up.
2. All that part of the said road allowance hereinbefore described and stopped up shall be sold to the adjoining owner.
3. The Reeve and CAO of the Corporation of the Township of Temagami are hereby authorized to sign or execute such Deeds or other documents as may be necessary to effect conveyance of that part of the said original road allowance hereinbefore described and which has been stopped up and closed.

4. There shall be attached to this By-Law as Schedule "B", the affidavit of John Hodgson, Chief Administrative Officer and Clerk of the Township of Temagami setting out the procedures taken for publishing and posting of the said notices pursuant to the provisions of the Municipal Act.

READ a first, second and finally passed upon third reading thereof this 19th day of July, 1993.

AFFIDAVIT OF THE CLERK

John H. Hodgson, being the person signing the Affidavit, has knowledge of the facts.

Information with respect to the publication and posting, with dates and particulars:

1. Public Notice of the proposed By-Law was posted for one month in six public places in the immediate neighborhood of the road being closed.
2. Public Notice was published once a week for four successive weeks in the local newspaper.
3. Notice to public council was posted forty-eight hours prior to meeting.
4. Confirmation from Public Works Canada, Ministry of Transportation, Ministry of Natural Resources, Ontario Hydro and Ontario Northland Telecommunications stating they had no interest in these lands.

The proposed By-Law came before municipal council on the 19th day of July, 1993 and no one appeared in person or by counsel to make representation with respect to the proposed By-Law.
