CORPORATION OF THE TOWNSHIP OF TEMAGAMI

BY-LAW No. 97-400

BEING a by-law to set fees for the municipally owned and operated boat launches within the municipal boundaries of the Corporation of the Township of Temagami.

WHEREAS the Corporation of the Township of Temagami deems it expedient to set fees for boat launches so that the cost of upkeep and good repair can be recovered through user fees,

AND WHEREAS Schedule M Section 220 of Bill 26, the Savings and Restructuring Act allows municipalities to pass by-laws imposing fees or charges, and Section 320 of the Municipal Act M.45 R.S.O. 1990 as amended provides for the penalties and enforcement of such by-laws,

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF TEMAGAMI ENACTS AS FOLLOWS:

- 1. That all boat launches that are maintained by the municipality have signs posted for the rules and fees associated with the use of the individual boat launch areas.
- 2. That fees shall be set from time to time by Council and such fees will be itemized on Schedule "A" to this Bylaw.
- 3. That rules governing the use of boat launches be set from time to time and such rules be itemized on Schedule "B" to this Bylaw.
- 4. The use of passes and report forms and notices shall be in the form as designated by Schedule "C" to this Bylaw.
- 4. That the Township develop a policy on the Management and long term care of municipal boat launches prior to the 1998 boating season.
- 5. The Township of Temagami may delegate to a private business the authority to levy the rates as provided for in Schedule "A" and the business will be entitled to a commission as determined by Council from time to time.

PENALTY CLAUSE

- 5. The Corporation of the Township of Temagami reserves the right to have vehicles, trailers, and or boats removed from the municipal boat launching area if the vehicles, trailers or boats are in violation of this Bylaw without the consent of the Township.
- 6. The cost of and any liability associated with removing, towing and storage of vehicles that are in violation of this Bylaw shall be born by the registered owner of the vehicle or trailer. Section 326 of the Municipal Act allows for the direction of costs.

REPEAL CLAUSE

7. Where the provisions of any other by-law, resolution or action of Council are inconsistent with the provisions of this by-law, the provisions of this by-law shall prevail.

APPROVAL CLAUSE

8. This bylaw shall come into effect when it has received third reading. There will be an implementation period to ensure public notice and education are fair and reasonable.

READ A FIRST AND SECOND TIME IN OPEN COUNCIL THIS 25th day of June, 1997

READ A THIRD TIME AND FINALLY PASSED THIS 25th day of June, 1997

- 1. Every Boat launch must have a sign that details the rules governing each launch area.
- 2. Vehicle and trailer parking will be either day use or paid parking. There will be no charge for day use parking of vehicles and trailers but Council reserves the right to charge for overnight parking as noted on the signage.
- 3. No person shall leave a boat on the boat launch ramp or in a location that impedes the orderly loading or off-loading of vehicles.
- 4. The use of the boat launch area is at the owner's risk and the Municipality does not assume any third party liability for any injury or damaged/ stolen property.
- 5. Any violation of this or any other part of this Bylaw will be prosecuted utilizing the Provincial Offences Court. Fines to be posted on the signage.
