#### Bylaw No. <u>98-418</u>

### THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

### being a by-law to designate an Acting Head for Council and assign Committees and Committee Responsibilities

**WHEREAS** subsection 69 (1) of the **MUNICIPAL ACT**, R.S.O.1990, c. M45 requires that Wayne Adair, Mayor for the Corporation of toe Municipality of Temagami is the head of the council and the chief executive officer of the corporation;

**AND WHEREAS** subsection 69 (3) of the **MUNICIPAL ACT** authorizes the council of any municipality to appoint, by bylaw a member of Council to act from time to time in the place of the head of council when toe head of toe council is absent;

**AND WHEREAS** Section 71 of the MUNICIPAL ACT authorizes the council of any municipality, with the written consent of the Head of council, appoint members of council to sit on boards, commissions, or other bodies of which toe head of council is a member by virtue of office, under any general or special Act, except a police services board;

**NOW THEREFORE**, the Council of the Corporation of the <u>Municipality of Temagami</u> enacts as follows:

1) That <u>Bill Kitts</u>, shall serve as toe Acting Mayor in the absence of Wayne Adair for the term of one year. Extension of the term or the rotation of the term shall be at the discretion of Council

2) The Mayor appoint Council representatives to various boards, commissions and bodies. The appointments and the designation of Committees of Council are contained on Schedule (1) of this bylaw and may be amended from time to time.

3) Resolution numbered <u>94-187</u> is hereby repealed.

4) This by-law shall ^ome into force and take effect on th^fr.h day of January, 1998.

**READ** asQCOJtd' and third time this <u>26th</u> day of <u>January</u> 1998.
