

**THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI**

**BYLAW NO. 98-435**

**BEING a bylaw to establish sewer rate charges for the Municipality of Temagami**

**WHEREAS** Section 221 (20) of the Municipal Act R. S. O. 1990 Chapter M- 45 allows a council of a local municipality to imposed upon owners or occupants of and who use sewage works a sewage service rate;

**AND WHEREAS** the Corporation of the Municipality of Temagami deems it necessary to set sewer service rates and fix times periods and frequency under which rates may be payable in accordance with Section 221 (25);

**NOW THEREFORE**, the Council of the Corporation of the Municipality of Temagami enacts as follows:

1. That sewer service rates be as set out in Sctiadute "A", attached to and forming part of this bylaw, and further that such Schedule may be altered from time to time by bylaw of the Municipality of Temagami at its sole discretion.
2. That the rates hereto set out in this bylaw be effective January 1, 1998.
3. That the sewer service rates shall be billed at a fixed rate separately on the interim and final tax billings and shall become due on the installment dates.
4. That there shall be imposed a penalty for non-payment of sewer service rate charges, on the due date of any instalment hereof, the amount of One Point Two Five (1.25) Percent on the first day of default, and on the first day of each calendar month thereafter on the balance remaining unpaid up to and including December 31.
5. If any section or portion of this by-law is found by a court of competent jurisdiction to be invalid, it is the intent of Council for the Corporation of the Municipality of Temagami that all remaining sections and portions of this by-law continue in force and effect.
6. That bylaw No. 89-230, 88-204, 86-161, 84-125, 83-94, 82-76, 77-6 as amended,

being bylaws to set <sup>sewer</sup>~~water~~ rates, be repealed.

7. That this bylaw shall come into full force on third and final reading.

Read a first and second time this 18th day of September 1998.
