

THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BYLAW NO. 98-434

BEING a bylaw to establish the prices for the use of water that is distributed by the Municipality of Temagami

WHEREAS Section 8 of the Public Utilities Act R.S.O. 1990 Chapter P. 52 allows a corporation of a local municipality to fix the prices for the use of water that they distribute and fix the times of payment, and further that Section 221 of the Municipal Act allows a corporation of a local municipality to fix rates;

AND WHEREAS the Corporation of the Municipality of Temagami deems it necessary to set water rates;

NOW THEREFORE, the Council of the Corporation of the Municipality of Temagami enacts as follows:

1. That water rates be as set out in Schedule "A", attached to and forming part of this bylaw, and further that such Schedule may be altered from time to time by bylaw of the Municipality of Temagami at its sole discretion.
2. That the rates hereto set out in this bylaw be effective January 1, 1998.
3. That the water rates shall be billed at a fixed rate separately on the interim and final tax billings and shall become due on the instalment dates.
4. That there shall be imposed a penalty for non-payment of water service rate charges, on the due date of any instalment hereof, the amount of One Point Two Five (1.25) Percent on the first day of default, and on the first day of each calendar month thereafter on the balance remaining unpaid up to and including December 31.
5. If any section or portion of this by-law is found by a court of competent jurisdiction to be invalid, it is the intent of Council for the Corporation of the Municipality of Temagami that all remaining sections and portions of this by-law continue in force and effect.

7. That this bylaw shall come into full force on third and final reading.
