- 3. This By-law shall come into force and take effect on the day of final passing thereof.

#### **CONSTITUTIONAL STATEMENT**

The following Amendment to the Official Plan of the Temagami Planning Area consists of three parts.

- Part A The Preamble, consisting of the purpose, location and basis of the Amendment, does not constitute part of this Amendment.
- Part B The Amendment consisting of the following text and map constitutes Amendment No. 8 to the Official Plan for the Temagami Planning Area.
- Part C The Appendices, consisting of the background data and planning considerations associated with this Amendment, does not constitute part of this Amendment.

#### **PART A - THE PREAMBLE**

#### **PURPOSE**

The purpose of this Amendment is to change the land use designation applying to lands located on Lakeshore Drive in Temagami South from 'Open Space, Culture, Recreation' to 'Low Density Residential' to permit the use of an existing building for residential uses.

#### **LOCATION**

This Amendment affects lands known as Lots 300 and 366 of Plan M-66 as shown on Schedule 'A' attached. The municipal address is 300 Lakeshore Drive.

#### **BASIS**

The property used to be the site of the former municipal office of the Township of Temagami. A new municipal office was constructed further to the east on Lakeshore Drive in the 1980's.

Given that the lands are now surplus to the municipality's needs, the lands are in the process of being sold to someone who wishes to reside in the existing building on the property. The lands to the west are the site of a residential dwelling and the lands to the east are the site of the Township public works yard. Lands to the north form part of the Sherman Mine lands and lands to the south, across Lakeshore Drive, are the site of the Ministry of Natural Resources complex and a number of residential and commercial uses. The use of the lands for residential purposes would be compatible with the existing uses in the surrounding area.

The policies of the Open Space, Culture and Recreation designation do not permit residential uses. Permitted uses in this designation are limited to active and passive and recreational uses. Given that the lands are no longer required by a public authority, it is deemed appropriate to redesignate the lands to the 'Low Density Residential' designation to permit the use of an existing building for residential purposes.

#### **PART B - THE AMENDMENT**

All of this part of the document entitled Part B - The Amendment, consisting of the following text and Schedule 'A', constitutes Amendment No. 8 to the Official Plan of the Temagami Planning Area.


Details of the Amendment

The Official Plan of the Temagami Planning Area is amended as follows:

#### Item 1:

Schedule 'A' of the Official Plan of the Temagami Planning Area is hereby amended by redesignating those lands shown on Schedule 'A' to this Amendment from the 'Open Space, Culture, Recreation' designation to the 'Low Density Residential' designation.
