BEING A BY-LAW TO AMEND BY-LAW NO. 98-434

1. **THAT** Section 1, which states; That water rates be as set out in Schedule "A, attached to and forming part of this bylaw, and further that such Schedule may be altered from time to time by bylaw of the Municipality of Temagami at its sole discretion, be amended with Schedule "A" attached hereto.
