THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BYLAW No. 99-450

Being a bylaw to rezone Parts 1,2 and 4 of Plan NR-2197 to permit industrial uses.

WHEREAS the Council of the Corporation of the Municipality of Temagami is empowered to pass bylaws to regulate the use of land in accordance with Section 34 of the Planning Act, R.S.O. 1990.

AND WHEREAS it is deemed appropriate to permit the use of lands within Parts 1, 2 and 4 of Plan NR-2197 for industrial purposes;

AND WHEREAS the proposed use of the lands within Parts 1, 2 and 4 will conform with the Official Plan as amended by Official Plan Amendment Number 9;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami enacts as follows:

- 1. That Schedule "A" of Bylaw 81-62 be and is hereby amended by rezoning lands described as Parts 1, 2 and 4 of Plan NR-2197 from the Residential Limited Service (RL), Open Space (G) and Heavy Industrial (HI) Zones to Industrial Exception Six Hold (I*6(H)) Zone as shown on Schedule "A" to the Bylaw.
- 2. That Section 6.0 of Bylaw 81-62 be and is hereby amended by the addition of the following sub-section:

"6.6 Notwithstanding anything to the contrary in the Bylaw, the following uses are permitted on the lands denoted by the symbol *6 on the schedules to the Bylaw

- automobile repair shop
- · bulk sales establishment
- · industrial uses
- open storage
- sawmill
- · scrap yard

All buildings and structures, parking and loading areas and outdoor storage areas shall be set back a minimum of 15.0 metres from the average high water mark of Link Lake. In addition, the following standards shall apply:

- minimum lot size 1.0 hectare
- minimum lot frontage 30 metres
- minimum front yard 9.0 metres
- minimum exterior yard 9.0 metres
- minimum interior yard 6.0 metres
- minimum rear yard 6.0 metres

In addition, open storage shall be set back a minimum of 6.0 metres from any lot line."


This bylaw shall come into force in accordance with the provisions of Section 34 of the Planning Act, R.S.O. 1990, c. P 13.

Lands to be re-zoned from the Heavy Industrial (HI) Zone to the Industrial Exception Number Six - Hold (1*6(H)) Zone




Lands to be re-zoned from the Open Space (G) Zone to the Industrial Exception Number Six - Hold (1*6(H)) Zone
