## **BY-LAW NUMBER 99-452**

## BEING a by-law to provide for an interim tax Kvy

WHEREAS Section 370 (8) and (9) of the MUNICIPAL ACT R.S.O. 1990, c M.45, as amended provides that die Council of a local municipality may, in 1999 before the adoption of the estimate for the year, pass a bylaw to le^y on the whole of the assessment for the real property according to the last revuied assessment roll, a sum not to exceed 50 percent of the total amount raised in 1998 in /ach of the following classes of assessment;

NOW THEREFORE the Council of the Coloration of the Municipality of Temagami hereby enacts as follows:

- An interim tax rate of 0.00547920 is he/eby imposed and levied on the whole of the assessment for real property in th^residential and farm classes, according to the last revised roll.
- 2) An interim tax rate of 0.0094055^is hereby imposed on the whole of the assessment for real property in the pipeline class.
- An interim tax rate of 0.001390 is hereby imposed on the whole of the assessment for the real property in the managed forest class.
- 4) The said interim tax levy khall become due and payable in 2 installments as follows:
  - 50 percent of the interim levy shall become due and payable on the 9th day of April 1999; and the balance of the interim levy shall become due and payable on 28th day of May, 1999. Non payment of the amount on the dates stated in accordance with ^his section shall constitute default.
- On all taxes ofme interim levy, which are in default on the 10th day of April, 1999, a penal^ of 1.25 percent shall be added and thereafter a penalty of 1.25 percent per frionth will be added on the day of each and every month the default continues, |4ntil December 31st, 1999.
- (a) Oh all taxes of the interim tax levy in default on January 1st, 2000, interest will be ^dded at a rate of 1.25 percent per month for each month or fraction thereof of default;

- (b) On all other taxes in default on January 1999, interest oRall be added at the rate of 1.25 percent per month or fraction thereof, and all by/aws and parts of by-laws inconsistent with this by-law are hereby rescinded.
- Penalties and interest added on all taxes of the interinnax levy in default shall become due and payable and shall be collected forthwith as if the same had originally been imposed and formed part of such/unpaid interim tax levy.
- 8) The collector may mail or cause the same to be mailed to the residence or place of business of such person indicated on the 1<sup>1</sup> revised assessment roll, a written or printed notice specifying the amount of tdxes payable.
- 9) That taxes are payable at the Corporation of the Municipality of Temagami Municipal Office, Temagami, Ontano.
- The Clerk-Treasurer is hereby authorized to accept part payment from time to time, on account, of any taxeythat have become due pursuant to this By-law. This By-law, in accordance with the provisions of the Municipal Act, permits the incorporation of water and/sewer billings, garbage billings and Full and Limited Fire Service billings to b/applied to the tax billing in a manner and amount determined by Council/
