THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI BY-LAW NO. <u>CO-51</u>: 2



A BY-LAW TO DESIGNATE A SITE PLAN CONTROL AREA ON CERTAIN LANDS IN THE GEOGRAPHIC TOWNSHIP OF JOAN NOW IN THE MUNICIPALITY OF TEMAGAMI, DISTRICT OF NIPISSING MORE PARTICULARLY DESCRIBED AS SUMMER RESORT LOCATION RW 3 BEING ISLAND 1022, IN LAKE TEMAGAMI AND DESIGNATED AS PARCEL 16859 IN THE PARCEL REGISTER FOR NIPISSING.

WHEREAS the Council of the Corporation of the Municipality of Temagami deems it desirable to designate a Site Plan Control Area in the Municipality of Temagami pursuant to Section 41 of the Planning Act, RSO 1990, C.P. 13;

AND WHEREAS the Council deems it desirable to delegate to the Clerk the authority to enter into an agreement respecting the matters referred to herein;

AND WHEREAS the Ministry of Municipal Affairs and Housing has approved a Minister's Zoning Order Amendment applying to the subject lands (Ontario Regulation No. 307/01) to permit the development of a tourist commercial use;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI HEREBY ENACTS AS FOLLOWS:

1. <u>DEFINITIONS</u>

In this By-Law:

- 1.1 **Municipality** means the Municipality of Temagami.
- 1.2 **Council** means the municipal Council of the Municipality of Temagami.
- 1.3 **Development** means the construction, erection or placing of one or more buildings or structures on land including docks or storage sheds or the making of an addition or alteration to a building or structure that has the effect of increasing the size or usability thereof, or the laying out and establishment of private sewage disposal systems, or the grading or alteration in elevation or contour of land, but shall not include a private water supply and maintenance building.
- 1.4 **Dock Area** means the area where a floating, post supported or cantilevered dock shall be located.
- 1.5 **Private Water Supply and Maintenance Building** means a structure to enclose a water pump and associated accessories, and which is not suitable for human habitation, and for the purpose of this By-Law is not development as defined in this By-Law.
- 1.7 **Sewage Disposal System** means any system that is subject to the Ontario Building Code (Ont. Reg. 403/97 as amended) or its successors.
- 1.8 **Site Plan Control Area** means the area designated by Section 2 of this By-Law.
- 1.9 **Storage Shed** means an accessory building or structure which is designed or used for the storage of hand tools, equipment or materials incidental to a tourist commercial use, and which is not suitable for human habitation, and for the purpose of this By-law is development as defined in this By-law.

2. DESIGNATED LANDS

That certain area of land being Island 1022, in Lake Temagami, in the Municipality of Temagami, and which is more particularly designated as Parcel 16859, District of Nipissing as shown on Schedule 'A', attached hereto and forming part hereof, is hereby designated as a Site Plan Control Area.

3. SITE PLAN AGREEMENT

- 3.2 The location of the recommended dock locations as shown on Schedule 'B'.
- 3.3 The size, location and type of sewage disposal system leaching beds shall be as shown on Schedule 'B'.
- 3.4 The location of existing natural tree, shrub and ground vegetation to be retained as shown on Schedule 'B'.
- 3.5 The location of natural ground and shrub cover to be retained at the shoreline within view/access corridors as shown on Schedule 'B'.
- 3.6 The location of view/access corridors not exceeding 5 metres in width between the shoreline and cabin sites as shown on Schedule 'B'.
- 3.7 The location of trail routes connecting cabin sites and between cabin sites and the shoreline not exceeding 2 m in width shall be as shown on Schedule 'B'.
- 3.8 Provisions requiring that no portion of a sewage disposal system leaching bed discharging effluent to the soil shall be located or installed closer than 20 m from the high water mark as shown on Schedule 'B'.
- 3.9 Provisions requiring that the Owner maintain all natural tree, shrub and ground vegetation as shown on Schedule 'B' except where limited clearing is required to provide sites for building and structures, locations for sewage disposal leaching beds, trail routes, and access/view corridors to the shoreline in order to maintain and protect the natural aesthetics of the Lake Temagami landscape. Clearing around buildings and structures shall be limited to within 3 m of building walls.
- 3.10 Provisions that no alteration of soil mantles and no alteration in elevation or contour of the land shall be permitted except where site landscaping and clearing is required to provide sites for buildings and structures, safe access within trail routes and locations for sewage disposal leaching beds.
- 3.11 Provisions requiring that the Owner maintain access/view corridors where no removal of natural flora ground cover or low shrubs is permitted within 3 m of the shoreline in order to maintain and protect riparian shrub vegetation.
- 3.12 Provisions specifying a timing restriction that no dock placement or construction or other in-water work be undertaken from May 15 to July 15 in order to protect potential smallmouth bass spawning.


