WORK DESCRIPTION:

Upgrade the Temagami North Water Treatment Plant and Temagami South Water Treatment Plant to comply with the Drinking Water Systems Regulation as follows:

For the Temagami North Water Treatment Plant, undertake the following capital works:

- 1. construct additional clearwell volume to ensure adequate disinfection;
- 2. install on-line turbidimeter and pH meters for raw water and treated water monitoring;
- 3. install two new package filter treatment plants (each at the existing plant capacity of 328 m³/d), including building addition to house the new package plants;
- 4. install standby chemical feed pumps (sodium hypochlorite, polymer, alum, and sodium bicarbonate);
- 5. replace two flow meters;
- 6. install a raw water temperature sensor; and
- 7. make clearwell hatches water tight;
- 8. plus related engineering.

For the Temagami South Water Treatment Plant, undertake the following capital works:

- 1. construct additional clearwell volume to ensure adequate disinfection;
- 2. install an additional package unit with coagulation, sedimentation and filtration;
- 3. install continuous turbidity, pH and temperature monitors for raw water supply;
- 4. connect the standby sodium hypochlorite metering pumps;
- 5. provide flow proportional and/or chlorine residual controlled sodium hypochlorite dosage;
- 6. provide filter-to-waste facilities;
- 7. isolate low lift pump discharge from clearwell;
- 8. provide flow proportional dosage for all process chemicals (alum, polymer and sodium hydroxide);
- 9. link turbidity, chlorine residual and pH to high lift pumps;
- 10. provide spill containment for process chemicals and diesel fuel;
- 11. install a standby filter backwash pump; and
- 12. install a flow meter for filter backwash flows;
- 13. plus related engineering.
