

# **THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI**

## **BY-LAW NO. 07-704**

---

### **Being a by-law to designate an Acting Head for Council and assign Committees and Committee responsibilities**

---

**WHEREAS** Section 224, 225 and 226 of Part 6 of the Municipal Act S.O. 2001, c.25, as amended requires that Ike Laba, Mayor for the Corporation of the Municipality of Temagami, be appointed as the head of Council and the Chief Executive Officer of the Corporation;

**AND WHEREAS** subsection 226 and 242 of the Municipal Act authorizes the council of any municipality to appoint, by by-law a member of Council to act from time to time in the place of the head of council when the head of the council is absent;

**AND WHEREAS** the Municipality of Temagami Procedural By-law authorizes appointment, with the written consent of the Head of Council, of members of council to sit on boards, commissions or other bodies of which the head of council is a member by virtue of office, under any general or special Act, except a police services board;


**NOW THEREFORE** the Council of the Corporation of the Municipality of Temagami enacts as follows:

1. That Bill Kitts shall serve as Acting Mayor in the absence of Ike Laba for the term of one year. Extension of the term or the rotation of the term shall be at the discretion of Council.
2. The Mayor appoint Council representatives to various boards, commissions and bodies. The appointments and the designation of Committees of Council are contained on Schedule "A" of this by-law and may be amended from time to time.
3. This by-law shall come into force and take effect on date of passage of this by-law.
4. That Schedule "A" of By-law No. 07-704 can be amended by resolution of Council.
5. That By-law No. 05-637 be rescinded.

Taken as read a first time this 22<sup>nd</sup> day of February, 2007.

Taken as read a second this 8<sup>th</sup> day of March, 2007.

Taken as read a third time and finally passed this 8<sup>th</sup> day of March, 2007.
