

**THE CORPORATION OF THE
MUNICIPALITY OF TEMAGAMI**

BY-LAW NO. 10-970

Being a by-law to appoint a member of the Council to act in the place of the Head of Council for Emergency Purposes, when the Head of Council is absent or refuses to act or if the office is vacant.

WHEREAS Section 242 of The Municipal Act, c.25, as amended, authorizes council to appoint a member of the council to act in the place of the Head of Council when the Head of Council is absent or refuses to act or if the office is vacant;

AND WHEREAS The Emergency Management and Civil Protection Act, R.S.O. 1990 Chapter E.9 Section 4(1), as amended, authorizes the Head of Council to declare an emergency;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI HEREBY ENACTS that Council authorizes a member of Council to act in the place of the Head of Council for the purposes of declaring that an emergency exists;


AND FURTHER THAT THE FOLLOWING ‘CHAIN OF COMMAND’ BE INSTITUTED:

1. In the absence of the Mayor, the Deputy Mayor may declare an emergency;
2. In the absence of the Mayor and Deputy Mayor, Council herein authorizes a member of council to act in the place of the Head of Council for the purpose of declaring an emergency, as detailed in Schedule “A”, affixed hereto and forming part of this By-law.
3. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.
4. That By-law No. 07-739 is hereby repealed.

Read a third time and Anally passed this 9th day of December, 2010.

**Schedule “A”
to By-law # 10-970
of the Municipality of Temagami**

Being a schedule to detail a “chain of command” in the absence of the Head of Council.

That in the absence of the Head of Council John Hodgson

The Deputy Mayor Lorie Hunter shall be charged with all of the responsibilities provided under the Emergency Management Act;

And in the absence of both the Head of Council and the Deputy, Councillor Deb Charyna shall be charged with the responsibilities provided under the Emergency Management Act;

And in the absence of all of the aforementioned elected members of Council, Councillor John Kenrick shall be charged with the responsibilities provided under the Emergency Management Act;

And in the absence of all of the aforementioned elected members of Council, Councillor Debby Burrows shall be charged with the responsibilities provided under the Emergency Management Act;

And in the absence of all of the aforementioned elected members of Council, Councillor Paul Middleton shall be charged with the responsibilities provided under the Emergency Management Act;

And in the absence of all of the aforementioned elected members of Council, Councillor Sam Barnes shall be charged with the responsibilities provided under the Emergency Management Act.
