# THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

#### **BY-LAW NO. 11-985**

Being a by-law to authorize the Clerk to execute an Agreement with the Ministry of Health and Long-Term Care and the Temagami Medical Centre Group for renewal of the Rural and Northern Physician Group Agreement.

WHEREAS under Section 8. (1) of the Municipal Act, 2001, S.O., 2001, c.25, as amended, the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

**AND WHEREAS** under Section 9 of the Municipal Act, 2001, S.O., 2001, c.25, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other act;

# NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

- 1. That the Clerk is hereby authorized and directed to execute the agreement attached hereto as Schedule "A" to this bylaw.
- 2. That the Clerk is hereby authorized and directed to execute any subsequent extensions to this same agreement.
- 3. This bylaw shall come into force and take effect upon final passing thereof.
- 4. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

Re: Rural and Northern Physician Group Agreement between Her Majesty the Queen in Right of Ontario, as represented by the Minister of Health and Long-Term Care, the Group Physicians as listed below (the "Group") and the Ontario Medical Association, dated April 1, 2005.

As you are aware, a working group comprised of members from the Ministry of Health and Long-Term Care (the "Ministry") and the Ontario Medical Association (the "OMA") have been discussing a new template for the Rural and Northern Physician Group ("RNPG") model (the "Working Group").

We are pleased to inform you that the Working Group has reached a consensus on its recommendations for enhancements to the RNPG model. These recommendations are intended to support the RNPG model by measures that include:

- providing additional funding to RNPG physicians through the expansion of certain permissible fee-for-service billing
- providing funding supports to communities experiencing physician shortages.

At this time, the Ministry and the OMA are preparing the new template agreement, which will incorporate the Working Group's recommendations as well as previous enhancements applicable to the RNPG model contained in the 2004 and 2008 Physician Services Framework Agreement.

Once completed, this template will be submitted for formal approval by the Ministry and the OMA. During this approval process, the draft template will be available for RNPG physician review.

In the interim, as your Agreement expired, the Ministry proposes to renew the Agreement until August 31, 2011, to permit the Ministry and the OMA sufficient time to complete the drafting of the new template.

- 1. Pursuant to subsection 8.1.1 (a), the Agreement shall be renewed commencing April 1, 2011 and expiring on the earlier of the following events: (i) August 31,2011; (ii) the date the parties execute a new funding agreement for the same or similar services; and (iii) termination in accordance with the provisions of the Agreement.
- 2. Unless explicitly defined herein, all capitalized words used herein shall be deemed to have the same meaning that they have in the Agreement.
- 3. In all other respects, the terms and conditions of the Agreement shall continue to apply.
