

THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BY-LAW NO. 11-998

Being a by-law to amend Bylaw 09-845 - to regulate the proceedings of Council of the Municipality of Temagami.

WHEREAS under Section 238 (2), the Municipal Act, S.O., 2001, c.25, c.M. 45, as amended, requires every municipality and local board to pass a procedure by-law governing the calling, place and proceedings of meetings; and

WHEREAS the Municipal Council of the Corporation of the Municipality of Temagami has enacted Bylaw 09-845 to govern the proceedings of Council; and to govern the calling, place and proceedings of meetings in accordance with Sections 238 (2), 239 and 251 of the Municipal Act, S.O., 2001, c.25, c.M. 45, as amended;

AND WHEREAS Section 7.4(b) specifies the timing for correspondence and petitions to be received for the council agenda, and Sections 7.7.3 and 7.7.4 of said by-law specifies the days and times that agenda items are to be available to Council and to the public prior to each Council Meeting, but these Sections do not address the need to adjust the specified dates and times when they fall on public holidays;

AND WHEREAS Council deems it appropriate that the necessary adjustments for public holidays be specified in the by-law;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

1. That Section 7.4(b) be deleted and replaced by:

Every petition or communication shall be delivered to the Clerk by the Thursday preceding the Council meeting at 4:30 p.m., but where the Friday preceding the Council meeting falls on a public holiday, every petition or communication shall be delivered to the Clerk by 4:30 p.m. on the Wednesday eight days prior to the Council meeting.
2. That the following section be added as Section 7.7.5 with the remaining section renumbered accordingly:


When the Friday prior to a Council meeting falls on a public holiday, the draft agenda package shall be posted for Council by 4:30 p.m. on the Thursday. When the Monday prior a Council Meeting falls on a public holiday, the public agenda packages shall be made available by 4:00 p.m. on the Tuesday.
3. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to this by-law, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

4. That this By-law shall take effect on the final passing thereof.
