

THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BY-LAW NO. 11-991

Being a by-law to authorize the Mayor and Chief Administrative Officer to execute an Amendment to the Agreement with Industry Canada / FedNor for a Youth Intern to work as an Economic Development Assistant for the Municipality of Temagami.

WHEREAS under Section 8. (1) of the Municipal Act, 2001, S.O., 2001, c.25, as amended, the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS under Section 9 of the Municipal Act, 2001, S.O., 2001, c.25, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other act;

AND WHEREAS Council authorized the execution of an Agreement for a Youth Intern with Industry Canada / FedNor for Project 842-508546 on the 27th day of May, 2010;

AND WHEREAS the Youth Intern originally hired under the agreement was unable to complete the term and another Youth Intern was hired;



AND WHEREAS to Council deems it desirable to accept the proposed amendment to the existing agreement with Industry Canada / FedNor to extend the term to allow for a full year contract for the current Youth Intern;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

1. That the Mayor and the Chief Administrative Officer are hereby authorized and directed to execute the Amendment to the Agreement attached hereto as Schedule "A" to this bylaw.
2. This bylaw shall come into force and take effect upon final passing thereof.

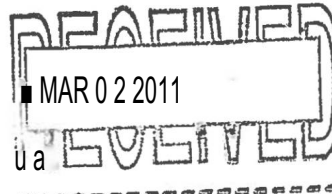

Amendment No.: 2

As a result of your letter of November 10, 2010 requesting permission to hire a new Intern for twelve months, FedNor is prepared to make the following amendment to our letter of offer of May 4, 2010, and subsequent amendment #1.

Delete: Clause 2.1 The Recipient shall ensure that the Project (the "Project") commences on or before August 30, 2010 (the "Commencement Date") and is completed on or before September 30, 2011 (the "Completion Date").

Substitute: Clause 2.1 The Recipient shall ensure that the Project (the "Project") commences on or before August 30, 2010 (the "Commencement Date") and is completed on or before March 31, 2012 (the "Completion Date").

Canada

Delete: Clause 3.1 The Minister will make a contribution (the "Contribution") to the Recipient in respect of the Project in an amount not exceeding the lesser of:

- a. 90% of the Eligible & Supported Costs of \$30,556 of the Project; and
- b. \$27,500.

Substitute: Clause 3.1 The Minister will make a contribution (the "Contribution") to the Recipient in respect of the Project in an amount not exceeding the lesser of:

- a. 90% of the Eligible & Supported Costs of \$40,545 of the Project; and
- b. \$36,490.
