BY-LAW NO. 11-1022

Being a by-law to authorize the Mayor and Clerk to execute an agreement with the Ministry of Health & Long Term Care for the provision of fire communication (call taking, call alerting and/or dispatching) services to the Municipality of Temagami by the North Bay Central Ambulance Communications Centre (CACC).

WHEREAS under Section 8 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, the powers of a municipality shall be interpreted broadly to enable it to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS under Section 9 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS the Council of the Municipality of Temagami deems it advisable to enter into an agreement with the Ministry of Health & Long Term Care for the provision of fire communication (call taking, call alerting and/or dispatching) services to the Municipality of Temagami by the North Bay Central Ambulance Communications Centre (CACC);

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

- 1. That the Mayor and Clerk are hereby authorized and directed to execute the agreement attached hereto as Schedule "A" to this bylaw.
- 2. This bylaw shall come into force and take effect upon final passing thereof.
- 3. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.
