BY-LAW NO. 13-1110

Being a By-law to amend Schedule "A" of Building By-law 08-782.

WHEREAS Section 7 of the Building Code Act, S.0.1992, as amended authorizes the Municipality to establish By-laws respecting Construction, Demolition and Change of Use Permits, Inspections, and to prescribe the amounts of the fees;

AND WHEREAS the Council of the Corporation of the Municipality of Temagami enacted By-law 08-872 on the 22nd day of May, 2008 and now deems it desireable to update Schedule "A" of said by-law;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

- 1. That Schedule "A" to Building By-law 08-782 be hereby repealed and replaced by "Schedule A" attached hereto and forming part of this by-law.
- 2. That this by-law shall come into force on the date of final passing thereof.
- 3. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

TAKEN AS READ A FIRST time on this 21st day of February, 2013.

READ A SECOND AND THIRD time and finally passed this 21st day of February, 2013.

SCHEDULE"A" As amended February 21, 2013

This is schedule "A" to By-law # 08-782 respecting: Building Permit Classes and fees

Building Permits

1- Residential fee formula (New Homes, sleep cabins, additions, carports, garages, boat houses, accessory buildings greater then 220 square feet in size and major renovations with a value of \$ 10,000 or higher)

\$9.00 per \$1000.00 of construction value or \$1.50 x the gross floor area of all floors, which ever is greater.

Minimum Permit fee: \$330.00

2 - Commercial/industrial fee formula (include additions and major renovations)

\$8.00 per \$1000.00 of construction value or \$1.20 x gross floor area of all floors or which ever is greater

Minimum Permit fee: \$330.00

4 - Plumbing Permit Fees shall be as follows: (no permit required if only changing fixtures)

(xvi) Basic Plumbing Fee

\$ 66.00

plus \$4.00 per fixture

fixture includes: water closet, bathtubs, shower stalls, washbasins, kitchen sinks, slop sinks, urinals, automatic washers, laundry tubs, drinking fountains, floor drains, roof hoppers and rain water leaders

5 - HVAC Permit Fees shall be as follows:

(xvii) New or Replacement/Alterations

\$110.00

(xviii) Special Ventilation Systems \$110.00 Includes commercial cooking exhausts, dust collectors, spray booth, etc.

6 - Administrative fees

- (xix) An area based fees where applicable will be added to the above permits as per the attached map.
- (xx) The area based fee will be calculated at the time the permit is issued using the following formula. # of required Inspections x additional time required x Hourly rate.
- (xxi) The area based fee for remote properties not cover by the attached map will be determined at the time the permit is applied for in consultation with the applicant.
- (xxii) Hourly rate for water based properties

\$70.00 (calculated to nearest % hr)

(xxiii) Hourly rate for road based properties

\$45.00 (calculated to nearest % hr)

(xxiv) There will be an annual renewal fee for all permits of \$100.00

7 - Refunds - Withdrawal of Application or Abandoned Application:

90% of the permit fee will be refunded if no review has occurred.

50% of the permit fee will be refunded if the permit has been issued.

Permit refunds of less than \$50.00 shall not be issued.

There will be no refund after 6 months.

There will be no refund if a permit is revoked under Section 8(10) of BCA.

Refunds will be paid to the owner named on the permit or to the person named on the receipt for payment.

Surcharge: A 100% surcharge applies to the above fees if permit application is received after work has begun.
