

THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BY-LAW NO. 13-1130

Being a by-law to regulate the receiving, dumping and disposing of waste and to repeal and replace By-law 93-317.

WHEREAS under Section 8 (1) of the Municipal Act, 2001, S.O., 2001, c.25, as amended, the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS under Section 10 (1) and 10(2) of the Municipal Act, 2001, S.O., 2001, c.25, as amended, a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public and may pass by-laws respecting those matters;
AND WHEREAS the Council of the Corporation of the Township of Temagami passed Bylaw No. 93-317 on the 10th day of June 1993 to regulate the receiving, dumping and disposing of waste;

AND WHEREAS the Council of Corporation of the Municipality of Temagami deems it desirable to repeal and replace said By-law;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

1. DEFINITIONS:

"Biomedical waste" shall mean whether solid or liquid, including but not limited to, any human organ or part thereof, bone, muscle, or human tissue or part thereof, used bandages, poultices, dressings, vials or any other similar material or substance which contains or may contain pathogenic microorganisms or which may be hazardous or dangerous; and any animal carcasses;

"Domestic Waste" shall mean the waste produced by residents in their homes;

"Recyclable/Recyclables" means cardboard, paper, glass, PETE plastic #1 through #7, aluminum / steel food cans and beverage containers;

"Hazardous waste" shall mean domestic, commercial and/or industrial waste materials that are toxic, corrosive, explosive, highly flammable, poisonous, reactive, radioactive or otherwise hazardous, including but not limited to chemicals, pharmaceuticals, biomedical waste, pathological waste, sewage waste, leachate toxic waste, and PCB waste;

"Landfill site" shall mean an approved sanitary landfill site operated by the Municipality of Temagami under a Certificate of Approval issued by the Ontario Ministry of the Environment.

"Pathological waste" shall mean, any part of the human body, including tissues and bodily fluids, but excluding extracted teeth, hair, nail clippings and the like, and fluids that are not infectious; any part of the carcass of an animal infected with a communicable disease or

suspected by a licensed veterinary practitioner to be infected with a communicable disease; non-anatomical waste infected with communicable disease; or any mixture of the above;

“Salvage” shall mean the process of finding items for the purpose of reuse;

“Scavenge” shall mean the process of finding items for the purpose of reuse;

“Transfer Station” shall mean a repository for solid waste operated by the Municipality of Temagami under a Certificate of Approval issued by the Ontario Ministry of the Environment, where solid waste is collected for transfer to an approved landfill site.

2. That the Waste Disposal Sites owned and or operated by the Municipality, including landfill sites and transfer stations, shall be subject to the terms of this bylaw, the Environmental Protection Act, R.S.O. 1990, Chapter E.19, as amended, the Regulations made under that Act, and any other applicable laws or regulation of Ontario and of Canada.
3. That Public Access to the municipal landfill sites shall be limited to the hours determined by the Municipality and posted at the site.
4. No person shall:
 - a) Deposit waste at any municipal landfill site outside the hours of operation as determined by the Municipality of Temagami and posted at the site;
 - b) Deposit waste produced outside the boundaries of the Municipality of Temagami, at any landfill site or transfer station, except that person has a current Non-resident's Landfill Card purchased from the Municipality of Temagami for that purpose.
 - c) Deposit at any landfill site or transfer station any waste which is dangerous or hazardous waste including, but not limited to, Household Hazardous Wastes (HHW) as listed in Appendix B of this By-law, which may be taken to the HHW Depot in North Bay; ;
 - d) Deposit any burning material or set any fire at any landfill site or transfer station;
 - e) Deposit waste at the gate or entrance to any landfill site or at any place within a municipal landfill site or transfer station other than the place designated for it's receipt thereat;
 - f) Neglect or refuse to provide proof of the origin of waste tendered for disposal at any landfill site or transfer station when such is demanded, provided that in lieu of providing such proof the person tendering the waste may remove it without unloading it;
 - g) Scavenge or salvage at any landfill site or transfer station;
 - h) Deposit waste at any landfill site while barred from doing so pursuant to Section 5 of this Bylaw.
5. No person shall attend at or trespass on any municipal landfill site for the purposes of depositing waste or for other lawful business, except with the express permission of the municipality. The municipality reserves the right to refuse access to the waste disposal site to any individual that the Municipality feels is in or may be in contravention of any part of this Bylaw. Every person depositing waste at any waste disposal site shall pay the tipping fee for the disposal of the waste that is in effect at the time of payment. In default of timely payment of tipping fees a user will be barred from access to the waste disposal site pending payment.
6. The Municipality or the employee of or attendant under contract with the Municipality who is designated by Council as being in charge of the landfill site or transfer station may at any


time order any person found scavenging or conducting in any other illegal activity on the landfill site or at the transfer station or having no lawful reason to be on the landfill site, or if they disobey the instruction of an on duty landfill site or transfer station attendant, to leave forthwith and if any such person fails or refuses to leave, may call for police assistance and cause trespass charges to laid.


7. That Tipping Fees shall be charged at the rates included in the User Fee By-law of the Municipality, which may be updated by the Municipality from time to time, and that the Municipality may provide for terms of payment thereof.
8. That Appendix A - Acceptable Solid Waste Streams, Appendix B - List of Household Hazardous Waste Materials, and Appendix C - List of Recyclable Materials, attached to this by-law for informational purposes and which may be updated by the Ministry of the Environment, the North Bay Household Hazardous Waste Depot, or recycling contractors, may be amended by a resolution of Council and do not require an amendment to this By-law.
9. That any person violating any provision of this Bylaw shall be guilty of an offence and shall be liable upon conviction to a fine not exceeding \$5,000, exclusive of costs.
10. That By-law 93-317 is hereby repealed.
11. That this by-law may be cited as the "Waste Management By-law";
12. That this bylaw shall come into force and take effect upon final passing thereof.
13. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

List of Household Hazardous Materials

The items listed below may be taken to the North Bay HHW Depot at no charge to Temagami households, as per an agreement with the City of North Bay.

Preparing HHW For Safe & Easy Transport

- All materials should be left in the original container to allow easy identification of the contents.
- Wastes should be sealed, labeled and not mixed.
- Bring all hazardous waste in a cardboard box or rigid container.
- Collect household batteries in a small bag, plastic container or coffee can.

How to Safely Transport and Depose of Your Biomedical Waste (Needles)

- Put all Needles/Biomedical Waste into a rigid container.
- Screw on the lid and tape the lid securely onto the container.
- Write, "SHARPS," in big block letters on the container.
- Bring your container to the HHW depot.

Appendix C to Waste Management By-law 13-1130

List of Acceptable Recyclable Materials

The Municipality offers four recycling depots located at Temagami South on O "Connor Drive, Temagami North on Spruce Drive (Arena parking lot), Temagami Mine Landing and Marten River landfill site.

Cochrane-Timiskaming Waste Management Board - Temagami North & South accepts the following items:

Paper Products - boxes are to be flattened before depositing; papers should be left loose, not tied with string.

- newspapers, magazines Pamphlets, flyers.
- Cardboard/boxboard
- Cereal boxes, old corrugated Cardboard and soap boxes

Aluminum/Steel Cans used for food and drink. Cans are to be rinsed before depositing.

Plastic Containers (PET)

- Bottles and all other plastic containers 1 through 7. Lids are to be removed and containers rinsed.

R & D Recycling-Temagami Mine Landing & Marten River Landfill accepts the following items:

Paper Products - papers should be left loose, not tied with string.

- Newspapers
- Magazines
- Computer Paper
- Pamphlets
- Flyers

Aluminum/Steel Cans used for food and drink. Cans are to be rinsed before depositing.

Plastic Containers (PET)

- Bottles and all other plastic containers I through 7. Lids are to be removed and containers rinsed.

Glass

- Glass Jars & Bottles (for food or drink)

Fibre- boxes are to be collapsed/flattened before depositing.

- Cardboard/Box board
- Cereal Boxes
- Soap Boxes
- Egg Cartons
- Tissue Boxes

ITEMS NOT ACCEPTED FOR RECYCLING

- Paper such as fax paper, wax paper, paper towels and cups, juice boxes.
- Metal such as spray cans, Paint cans, coat hangers, Batteries, metal pots and pans, aluminum foil and plates.
- Glass such as drinking glasses, cups, Dishes, window glass, light bulbs Mirrors, pottery, glass pots and pans.
- Plastic such as containers used for Hazardous chemicals, motor oil jugs, All plastic material, which does not have the symbol.
