

**THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI**

**BY-LAW NO. 13-1142**

---

**Being a by-law to amend By-law 09-826, being a by-law to provide for the regulating of traffic and vehicle parking, rate of speed, standing and stopping on highways or parts of highways under the jurisdiction of the Corporation of the Municipality of Temagami.**

---

WHEREAS under Section 8.1 of the Municipal Act, 2001, S.O., 2001, c.25, as amended, the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

WHEREAS the Council of the Corporation of the Municipality of Temagami passed by-law 09-826, on the 26th day of February, 2009, under authority of the Municipal Act, 2001, S.O. 2001, c. 25 and Sections 128 and 137 of the Highway Traffic Act, R.S.O. 1990, Chapter H.8 as amended;

AND WHEREAS the Council of the Corporation of the Municipality of Temagami passed resolution 13-346 on the 8th day of August 2013, directing staff to draft an amendment to Schedule L of the traffic and vehicle parking By-law 09-826 to prohibit transport truck parking in the Temagami Train Station Parking Lot;


NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

1. That SCHEDULE L - DESIGNATED MUNICIPAL PARKING LOTS - to Bylaw 09-826 as amended be replaced by the SCHEDULE L attached hereto and forming part of this by-law.
2. That this bylaw shall come into force and take effect upon final passing thereof.
3. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

**BY-LAW NO. 09-826**

**SCHEDULE“L”**

**DESIGNATED MUNICIPAL PARKING LOTS**

The following locations in the Municipality of Temagami are designated as overnight Municipal Parking Lots as signed:

1. O'Connor Drive Public Parking Lot.
2. Steven's Road Public Parking Lot (across from the ambulance station)
3. Cassels Lake Boat Launch area Public Parking Lot.
4. Public Parking Lot at the west end of Memory Lane.
5. Temagami Marine Road Boat Launch.
6. Temagami North Arena Parking Lot.
7. Lake Temagami Access Road Mine and Manitou Landings (LUP #LTE 397)

The following locations in the Municipality of Temagami are designated as day use only Municipal Parking Lots as signed:

1. Temagami Waterfront Parking Lots.
2. Wildflower Avenue and Lakeshore Drive intersection Parking Lots.
3. Stevens Road Parking Lot by the Ball Diamond.

The following locations in the Municipality of Temagami are designated as day use only and no transport trucks Municipal Parking Lot as signed:

1. Temagami Train Station Parking Lot.
