## THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

#### **BY-LAW NO. 13-1145**

## Being a by-law to designate an Acting Head for Council and to assign Board and Committee responsibilities.

WHEREAS Section 225 and 241 of Part 6 of the Municipal Act S.O. 2001, c.25, as amended includes in the role of the Head of Council, the duty to act as Chief Executive Officer of the municipality; and to preside over council meetings;

**AND WHEREAS** subsections 226 and 242 of the Municipal Act authorize the council of any municipality to, with the consent of the head of council, appoint a member of council to act in the place of the head of council on any body, other than on the council of another municipality, of which the head of council is a member by virtue of being head of council; and to appoint a member of the council to act in the place of the head of council when the head of council is absent or refuses to act or the office is vacant, and while so acting such member has all the powers and duties of the head of council;

**AND WHEREAS** the Municipality of Temagami Procedural By-law authorizes Council to appoint the Chairs of the Standing Committees of Council;

**NOW THEREFORE** the Council of the Corporation of the Municipality of Temagami enacts as follows:

- 1. That John Kenrick shall serve as Acting Head of Council in the absence of Mayor Lorie Hunter Mayor and shall be known as the Deputy Mayor.
- 2. That Council members be appointed to represent the Municipality on various boards, commissions and bodies and to Standing Committees of Council as listed on Schedule "A" of this by-law and may be amended from time to time by resolution of Council.
- 3. That By-law No. 10-969 is hereby repealed.
- 4. That this by-law shall come into force and take effect on the final passing thereof.
- 5. That the Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to the by-law and schedule, after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.
