## THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

### **BYLAW NO. 25-1823**

Being a By-law to amend Schedules A, C and E of By-Law 23-1698, as amended, a By-law to Regulate and Control Traffic, Parking, and Heavy Trucks within the Municipality of Temagami.

#### **WHEREAS**

- 1. Section 11(1), paragraph 8 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipality may pass by-laws respecting matters related to parking and traffic within its jurisdiction; and
- 2. The Municipality of Temagami wishes to update the designation and use of municipal parking lots and on-street parking spaces, and set related user fees;

### **NOW THEREFORE**

The Council of the Corporation of the Municipality of Temagami enacts as follows:

### 1. Repeal of Existing Schedules

That Schedules "A", "C", and "E" of By-law No. 23-1698 are hereby repealed in their entirety.

### 2. Adoption of Revised Schedules

That Schedules "A", "C", and "E" attached hereto and forming part of this By-law are hereby adopted and shall replace the corresponding schedules of By-law No. 23-1698.

## 3. Clerical Amendments

The Clerk of the Municipality of Temagami is hereby authorized to make minor modifications or corrections of a grammatical or typographical nature to this By-law and its schedules after its passage, provided that such modifications do not alter the intent of the By-law.

### SCHEDULE "A" TO BY-LAW 23 - 1698 - DESIGNATED PAID PARKING SPACES AND LOTS

The following locations in the Municipality of Temagami are designated as overnight Municipal Parking Lots as signed:

The paid parking lots are 4 hour and daily fees in accordance with the Municipality' most recent Municipality's most recent Fees and Charges By-law:

- 1. Townsite Railroad Bridge Parking Area
- 2. O'Connor Drive Public Parking Lot.
- 3. Steven's Road Public Parking Lot (across from the ambulance station)
- 4. Cassels Lake Boat Launch Area Public Parking Lot.

- 4. Temagami Train Station Parking Lot

Fees shall be charged in accordance with the Municipality's most recent Fees and Charges Bylaw

## Schedule E - By-Law 1823

### SCHEDULE "E" TO BY-LAW 23 – 1698 - DESIGNATED PAID PARKING ZONES

- 1. There are designated and signed parking spaces at the Lake Temagami Mine Landing (LUP #LTE 397) that the Municipality charges an annual fee as per the current Fee and Charges Bylaw.
- 2. The south side of Lake Temagami Access Road, from the Lake Temagami Mine Landing to 500 metres east of Boatline Bay Marine, shall be subject to daily and weekly fees as per the Municipality's most recent Fees and Charges By-law.
