THE PURPOSE AND EFFECT of the application is:

To permit the reconstruction of the existing legal non-complying dwelling on the property. The proposed new dwelling is slightly larger than the existing and is two stories in height. The existing dwelling is located 4.5 metres from the shoreline.

Due to the size and shape of the subject property, the entirety of the subject property is located within the Shoreline Activity Area which is measured 15 metres from the shoreline. The existing dwelling is considered legal non-complying because it is located within 15 metres from the shoreline which is the minimum setback from the shoreline in the Residential Lake Temagami (R1) Zone.

In order to permit the proposed development, the following variances are required:

Section 6.28:

To permit the reconstruction and expansion of a legal non-complying dwelling and within the Shoreline Activity Area. The footprint of the existing dwelling is to be increased from 55 square metres to 65 square metres.

Section 6.40:

To permit the maximum area of buildings and structures located within the Shoreline Activity Area of 130 square metres, where 100 square metres is permitted. This includes the proposed dwelling, deck and accessory buildings/structures.

Section 7.4.2 - Dwelling Unit - a)

• To recognize the existing setback of 4.5 metres from the shoreline and a proposed setback from the shoreline of 5 metres, where a minimum distance from the shore of 15 metres is required.
