The owners have submitted a Consent application to create a new lot on the subject property. Based on the sketch submitted with the application, the subject property currently has a lot area of 0.56 hectares and a lot frontage of 145 metres. There are currently two existing dwellings on the subject property and each of the dwellings are serviced by their own water supply and septic system. The owners are proposing to separate the existing dwellings and to create separate lots, and no new buildings or structures are proposed as a result of the application.

The subject property and the proposed lot configuration sketch are shown in the "Key Maps" section of this Notice. The Retained Lot is proposed to have a lot area of 0.42 hectares (1.04 acres) and a total lot frontage of 110 metres. The Severed Lot is proposed to have a lot area of 0.14 hectares (0.35 acres) and a lot 65 metres. The proposed lot frontages are measured in accordance with the Zoning By-law. The proposed lot configuration sketch shows the legal boundaries of the subject property, and there are lands located outside the legal boundary of the subject property that are above the current shoreline of Lake Temagami.
